Administer acetaminophen 1,000 mg intravenously over 10-20 minutes. Give midazolam 1-2 mg intravenously as needed for anxiolysis. Anesthetic Induction. Begin intravenous lidocaine infusion (0.03 mg/kg/min) and dexmedetomidine infusion (0.5 mcg/kg/hr) after monitors are in place.

The proposed pharmacopeia for multimodal general anesthesia includes a host of anaesthetic adjuncts including opioids (e.g. remifentanyl), alpha-2 agonists (e.g. dexmedetomidine), local anaesthetics (e.g. lidocaine), and N-methyl-D-aspartate receptor antagonists (e.g. magnesium, ketamine).

Intravenous (IV) opioids are commonly used to provide analgesia and supplement sedation during general anesthesia or monitored anesthesia care (MAC), and are the most widely used agents for treatment of acute pain in the immediate postoperative period.

Generally, HSAN II, IV, and V patients do not need opioids postoperatively even after major operations. Because these disorders are so infrequent, it is impossible to conduct large-scale studies. In the interim, we will continue to learn from the anesthesia experience reported in individual cases.

Peripheral nerve blocks and neuraxial anesthesia can reduce the need for opioids and have an opioid-sparing effect. In addition, although usually expensive, drugs such as esmolol 28 and dexmedetomidine 29 can approximate the effect of opioids on heart rate, blood pressure control, and volatile anesthetic requirement.

Since the 1960's, intraoperative administration of opioids is considered a keystone of anesthesia as well as hypnotics and muscle relaxants. Synthetic opioids were introduced to achieve hemodynamic stability during anesthesia. They allow an inhibition of the sympathetic system without cardiovascular collapse and histamine release.
